PLEASE READ THIS FIRST!

Nothing is more frustrating these days than trying to get an actual human being to answer the phone when you call organizations for assistance. This can especially be true for government agencies. If this happens to you when contacting any of the service providers listed in this Reentry Resource Guide, remember the following:

- Try to find all the information you need on the service provider's website, which OurJourney gives for every service provider that has one. That way you won't even need to call. If the website gives an email address, you might try emailing the service provider with your non-emergency questions.
- Sometimes by pressing the zero button on your phone you can skip past the recorded message and be sent straight to a human operator.
- Know ahead of time exactly what you want to ask; have any materials you need on hand before you call (such as ID, application, etc.).
- Be patient. If you simply can't wait on hold any longer, choose the option that lets you leave a voicemail (if available).
- If you leave a voicemail, remember to state your name and phone number clearly, along with the reason for your call.
- Make sure you're available for call-back during normal business hours. If you can't be, when you leave your voicemail provide a time range for call-back.

Also remember, many people in your community need help too. So you may be placed on a waiting list for some services. OurJourney always recommends that you begin your search for assistance by contacting the One-Stop Resource Centers listed at the front of this guide. Why? Because these service providers usually have the resources and connections in the community to provide more immediate and specific help.

Agencies, organizations, ministries or businesses with a  beside their listing are close partners of OurJourney. We have verified not just their basic information but that they are dedicated to helping you rebuild your life. Make sure you mention that OurJourney sent you!

Finally, remember that your success ultimately depends on **YOU!** OurJourney encourages you not to give up if you can't find help when and how you need it. We know firsthand how frustrating it can be when things don't go the way you hope, but we also know that **the worst day in freedom is better than the best day in prison**, and that patience and perseverance are just as important to your success as the assistance you need.

North Carolina ePASS is a new online way to apply for Benefits and services as a resident of the state. It is made available by the NC Department of Health and Human Services.

You can apply for Food & Nutrition Services, apply for Energy Assistance, register to vote (if eligible) and apply for other state services.

You will need to set up an account first and you must have an active email account. You will also need a photo ID and your birth certificate to set up an account.

Setting up an account is free. To qualify for benefits, you must meet certain guidelines.



Recidivism Reduction Educational Programs Services, Inc. (RREPS)

Founded by formerly incarcerated activist Kerwin Williams, RREPS provides support to individuals returning after incarceration. RREPS can help you obtain proper identification from various state and federal agencies.

Through their Transitional Partners (TP) program, they may be able to connect you with a formerly incarcerated person in your area who can help you navigate reentry.

To request assistance, visit the RREPS website, click on the "About" tab, then click on "Contact" and fill out the form with your information. For the field labeled "Focus Area," select "Recidivism Reduction" from the dropdown menu. For the field labeled "Subject", enter "Need Help" and for the field labeled "Message" enter whatever you'd like to say about your current situation. Then click on "Submit". Kerwin and his team will respond to your message within 24 hours.

Provides food to those in need, along with other services, such as help paying certain bills and limited medication assistance. Individuals or families select items in the Client Choice Food Pantry based upon eating preferences; each food order is designed to provide nutritious meals that will last for a two-week period. Must have access to a refrigerator. Specific foods provided are determined by inventory levels and donations. You must register first. To register you'll need to bring your ID with you (prison ID is accepted) and a letter or note from your parole officer verifying your need if you don't have any proof of residency. There may be other documents you'll need to bring, so call first. They also provide free prescription medication to those who qualify. (See **Medical/Dental Resources** for more information.) **Always check with your Parole Officer before leaving Stokes County.** Free

Eligibility screening is only on Tuesdays and Wednesdays from 1:00 to 4:00 PM

Provides primary health care services and medicines to uninsured patients who don't qualify for federal or private insurance and have family incomes below 200% of the Federal Poverty Level. Applicants must come for an initial eligibility screening and be approved before they can receive assistance. You must show proof of residency (which can include anything from your parole officer) and show your ID (prison ID accepted).
Their application is on the website. You MUST make an appointment! They do not provide emergency care and cannot meet every medical need.

Parks Insurance is licensed in all 50 states to offer healthcare insurance to individuals returning from prison. Through a special program called G.I.F.T. (Giving Insurance Freely for Transition), you are eligible to receive healthcare insurance with ZERO monthly payments and little, if any, deductibles. This plan covers doctor visits, medication, behavioral health, surgery, hospital stays and more. Everyone qualifies, even those with preexisting conditions.

NC MedAssist is a statewide program for those who do not have the means to buy life-saving medications to treat chronic diseases such as heart disease, diabetes, and asthma. To qualify you must live in NC, not have any insurance (not even Medicaid) and have income that is at or below 300% of the national poverty average. (To give you an example, if you live with one other person, the combined yearly income for both of you can't be more than \$54,930, or \$4,577 per month.) Visit their website to enroll or call for more information. They also have a Mobile Free Pharmacy that travels the state handing out free Over The Counter medications to anyone, no ID required.

To set up an initial consultation call Monday through Friday from 8:00 AM to 5:00 PM

Offers therapy for those on methadone that promotes positive self-image and identity, helps teach proper social behaviors, and encourages decisions made from a higher level of moral judgment. Services include substance misuse treatment, cognitive behavioral intervention, educational assistance, and employment services. Call to set up an initial consultation appointment, which will last between 2 to 3 hours. You must bring your ID with you (prison ID accepted). They offer a 90-day residency program to those on methadone that is strict but effective to those who are approved to participate. **Always check with your Parole Officer before leaving Stokes County.**

The cost for treatment varies considerably from one treatment provider to the next. Funding for many of services is provided by state programs. If you do not have insurance, your services may be eligible for funding through various state-funded programs. This can be determined as a part of the assessment process

Provides a structured residential setting for men recovering from substance use disorders. It is a two-year program with a nine-month residency component followed by 15 months of aftercare.

They do not accept those convicted of sex offenses or murder or those who are on any prescription drugs to help with drug addiction (such as methadone or suboxone). You can either fill out their application online or go in person to their address and fill it out. Must come with a Substance Use Disorder Assessment, which you may get free from Daymark (see listing below.)

Always check with your Parole Officer before leaving Stokes County.

The Fellowship Home charges a fee of \$100 per week. All residents are required to work; and if unemployed, are first tasked with finding employment. All activities are scheduled in the evenings and new residents are required to work a first-shift job. No resident will be admitted working a second- or third-shift job

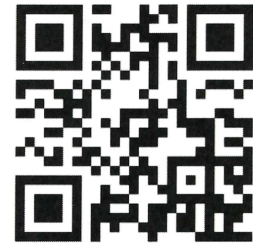

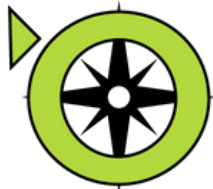
